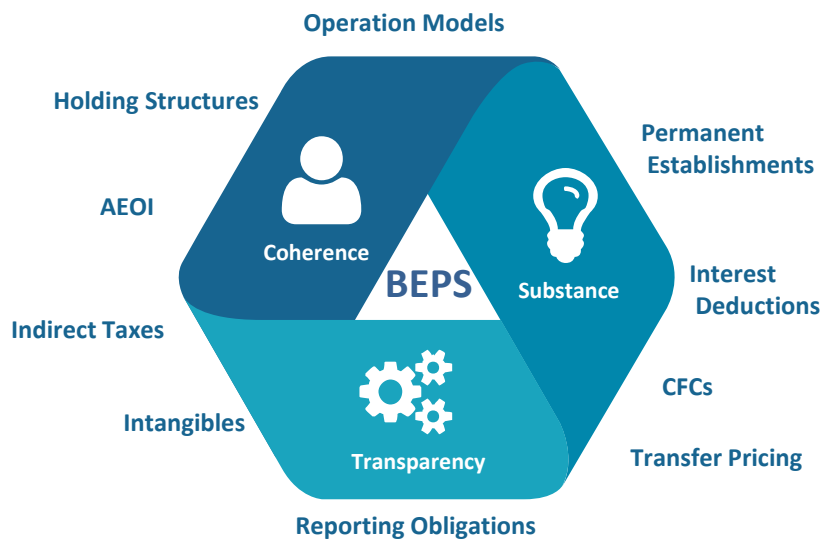

## ENFORCEMENT PERIOD OF OECD BEPS ACTION PLAN HAS BEGAN

OECD BEPS Action Plan has been mostly concluded and as of 2016 the enforcement period where important changes in relation to BEPS are conducted at international and local level has began.

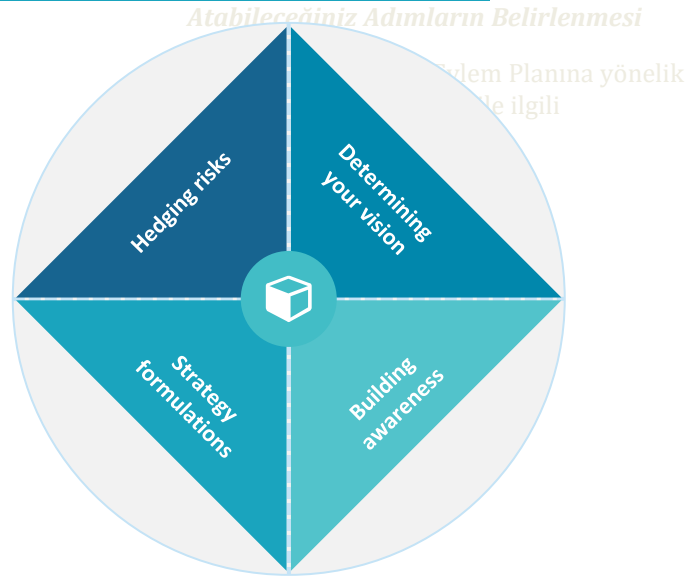
